We have enclosed the final Budget for the 14th Ohio Roundup along with a check for the seed money and money raised over and above expenses. We are pleased to have raised \$3,131.94 over the \$2,000.00 in seed money to be dispursed pursuant to the Ohio Roundup Charter.

We are also enclosing a letter which we received from the Chair of our Scholarship Committee, R. Michael F.. Michael did not attend our wrap up meeting on November 16th and therefor has not seen the final Budget. We were not aware of any problems with the donations submitted by either Karen K. nor the Toledo donation.

We refunded all those who requested refunds on registrations. We budgeted for 16 full scholarships and 30 some partials. We provided 18 full scholarships and 33 partials for a total of 51 scholarships. No one who requested a scholarship was turned away and we had no intentions of denying anyone. All donations totaled \$736.61. The 14th Ohio Roundup alloted approximately \$1,100.00 of our projected budget for scholarships. The total costs of the scholarships was \$2,046.86. We exceeded both our projected costs plus all donations by approximately \$210.00. No one has requested a refund on their donations. We have no objections to the State Steering Committee refunding anyone their donation upon request. All of our records, registrations, checks etc. are available for the Committees review.

The 14th Ohio Roundup feels proud to have provided 51 scholarships and not to have had to turn anyone away. Over 20% of those who attended did so on a scholarship. We are also pleased to have exceeded our expenses and are able to provide funds for future Roundups and AA as a whole.
