

STATE STEERING COMMITTEE MEETING
FEBRUARY 22, 1998 MINUTES

MEETING OPENED WITH THE SERENITY PRAYER BY CHAIR-PERSON VAUGH B. AFTER WHICH HE WELCOMED ALL IN ATTENDANCE.

MINUTES FROM AUGUST 23, 1997 WERE READ BY FRANK W. OUT GOING SECRETARY. MOTION MADE TO ACCEPT MINUTES AS READ AND SECONDED. ALL IN FAVOR.

MOTION MADE TO ACCEPT REPORT AND SECONDED. ALL IN FAVOR.

FURTHER DISCUSSION ENTAILED REGARDING THE DISBURSEMENT OF FUNDS PER THE STATE CHARTER. THE CHARTER DESCRIBES THE FOLLOWING DISBURSEMENT:

- 1.50% TO THE ROUND-UP STEERING COMMITTEE
2. 20% TO THE STATE GENERAL SERVICE FUND
3. 20% TO THE INTERNATIONAL ADVISORY COUNCIL
4. 10% TO THE WORLD SERVICE

THERE WAS DISCUSSION BY THE TREASURER WITH REGARD TO THE NEED TO HOLD ON THE MONIES DESCRIBED OR SHOULD THE DISBURSEMENT BE DONE. A MOTION WAS MADE TO DISBURSE THE MONIES AS ABOVE AND THE REMAINING 50% MINUS THE \$2000.00 SEED MONEY FOR THE NEXT ROUND-UP, WOULD BE DEPOSITED INTO ANOTHER TAX DEFERRED CD 4 MONTHS FROM NOW. THIS WOULD BE SO THAT THE PRESENT CD AND THE NEW CD WOULD MATURE 6 MONTHS FROM EACH OTHER AND WOULD ACCOMMODATE ANY NEEDS THAT ARISE AND THE WITHDRAWAL WOULD NOT BE PENALIZED. THE MOTION WAS SECONDED. ALL IN FAVOR.

RICHARD THANKED ALL WHO HELPED MAKE THE ROUND-UP A SUCCESS AND IS LOOKING FORWARD TO THE 16TH OHIO ROUND-UP IN CLEVELAND AND OFFERED ANY HELP OR SUPPORT THAT TOLEDO COULD OFFER.

VAUGHN B. CHAIR THANKED TOLEDO FOR A WONDERFUL JOB AND A GREAT WEEKEND.

THE TAX EXEMPT LETTER HAS BEEN HELPFUL AND THEY WILL MAKE SURE THAT A COPY IS PROVIDED TO COLUMBUS.

RICHARD M. TOLEDO CHAIR PROVIDED INFORMATION IN REGARD TO THE ESTABLISHED CREDIT WITH THE HILTON HOTEL AT THE 15 TH OHIO ROUND-UP.
