# 31st Ohio Roundup Report – Canton

**Canton Co Chair – Lisa Y.** 

Lisa reported for the Canton Roundup:

- The First Merit account is reconciled as of 04/30/2013
- Balance as of 05/24/2013 \$3,369.45
- They are planning on using Square Up credit card readers for transactions
  - Thank you to Robert G.
- A payment of \$393.00 was sent to Shoff Darby for event insurance on 04/18/2013, they are still waiting on the
  certificate to arrive
- They are using the tax-exempt forms for purchases.

Toledo up-date Kate J.

Kate deferred to Richard M.

Richard provided the following update;

- Richard provided a copy of the budget for the 2014 Ohio Roundup
- The group went through the budget in detail
- The budget will be approved with the Bid Packet presented at the Roundup in August 2013

Old Business Harry S.

- 1. The Treasurer will provide information on the amount ORSC spent over the last 3 years to determine the amount that should be kept in the ORSC checking account.
  - a. Steve presented the expenditures from 2007 through 2012 and estimated 2013
  - b. Steve suggested that the State Steering Committee keep \$3,000.00 in the treasury
  - c. After some discussion a decision was made to hold \$5,000.00 in the treasury
  - d. A motion to keep \$5,000.00 in the treasury was made by Richard M., second by Patrick H. motion was approved

### 2. Treasurer – Steve will check into Fiduciary Bonding

- This is a recommendation from the accountant
- If the ORSC Treasurers were bonded, ORSC could recoup any losses
- This could be handled with the current insurance carrier
- Steve will provide a report at the June 2013 meeting
  - The ORSC original application was denied by Shoff Darby
  - Steve's recommendation was to not secure the Fiduciary Bonding based on the fact that the ORSC would have to have a Financial Secretary other than the Treasurer make a monthly financial report to the committee that will need to be audited by a CPA
  - The committee agreed with the recommendation
  - Steve was asked to draft an e-mail of the ORSC decision at this time outlining why the decision was made, a copy of the e-mail is below:

Frank.

Richard asked that I send an e-mail updating you (and Denise) with the outcome of our inquiry into fiduciary bonding with Shoff Darby. At today's ORSC meeting I reported to the committee that our application for crime insurance was denied. For approval, the insurer requires a copy of our business plan/by-laws showing that we split the financial responsibilities so that a CFO (Treasurer) & CEO (Chair) are required signors on all financial transactions (which we are doing) *and* that a separate Financial Secretary provides a monthly financial report to the committee that has been audited by a CPA.

The latter requirement would likely result in creation of separate positions at both local and state levels, amendments to the bylaws and an extra level of administration in the form of more frequent reports and accountant fees. After discussion, we did not have any expressed interest in pursuing fiduciary bonding at this time.

### **Akron Report**

Scot B. and Wayne B. from Akron continue to reach out to the Akron community.

- Cleveland Delegates confirmed that they would allow Akron to submit and intent to bid which would allow Cleveland to push back to 2016 where they would have been originally.
- Akron has stated they will present an intent to bid at the Canton Roundup in August
- They have selected a Hotel at The Akron Civic Center
- They have support letter from Key Officials in the community:
  - A Senator
  - o The Mayor
  - Historic Society
- Discussion included obtaining Letters of Support from:
  - Akron Intergroup
  - o GLBTQ AA Groups signed by its members
  - o Guidelines provided by ORSC for submitting and Intent to Bid to the ORSC.

#### **Contract from the Accountant**

Richard presented the contract from the Accountant – Professional Tax and Bookkeeping

- This is the first that the Accountant has asked for a contract
- The contract outlines the services that are being provided
- These are the same services that have been provided over the past few years
- The Accountant just wanted us to have an agreement in writing
- Scot B. made a motion to accept the contract, Rob G., second, motion passed
- Harry signed the contract
