- Income was budgeted at \$26,510, Actual was \$14,154
- Expenses were budgeted at \$25,783, Actual was \$9,166
- Net Profit was budgeted at \$727, Actual was \$4,987

36th Ohio Roundup (Canton 2018) Host Update

Lisa Y.

Lisa Y., Host Committee Chair, reported:

- \$5,181.64 balance in the Host Committee bank account
- 2 registrations from Cleveland
- 5 hotel reservations made so far
- There will be no mugs for sale at the 36th Ohio Roundup
- The Committee is possibly looking at selling embroidered messenger bags for around \$15-\$20
- On 8/22/18, the Committee must pay the hotel for the brunch/food this will be based on the registrations
- There is a fundraiser May 12th, 4:00 pm, for a Drag Bingo fundraiser featuring Tina Hightower
- An Ice Cream Social fundraising event will be held March 3rd
- An early June "Pot Party" Landscape designing potted flowers Fundraising event will be held
- A future fundraiser might be a Resentment "axe-throwing" event
- Fundraisers are averaging \$85-\$100 per fundraising event
- As of today (02/26), there have been 14 registrations
- The goal for registrations is 110-120
- 30 registration forms were sent to Toronto AA per their request
- The Committee is currently filling out the Event Insurance form
- Conference Social Activities planned
 - FRIDAY night: Drag Bingo with Tina Hightower

- The Alkathon will be an Open event, there will not be a sign-up
- Chris S. will be sending an e-mail asking for workshop presenters

37th Ohio Roundup (Toledo 2019) Bid Update

Phil W., Bid Committee Chair, reported:

- \$500 seed money was received from the ORSC Treasurer
- Bank account was opened as a subsidiary account of the ORSC
- The hotel (Holiday Inn French Quarter; Perrysburg, OH) has been secured. A contract has been signed, and an initial deposit has been paid.
 - Room rates will be \$99/night
- The entire Bid Committee has been formed
- The next Bid Committee meeting is scheduled for April 7th
 - Approving a budget is on the agenda for the April meeting
- A search for the conference theme and logo has been started

III. PRIMARY PURPOSE - CONFERENCE

The Committee discussed the AA Primary Purpose and the Singleness of Purpose as it relates to the Ohio Roundup.

- In the Canton/Akron area, certain groups are having a conflict with their Intergroup office when they identify and state in their closed AA meeting scripts that their meeting is for problems with "alcohol or drugs."
 - The local Intergroup office has threatened to pull groups from the local directories if they continue to state that the meeting is for "alcohol or drugs," citing the AA Singleness of Purpose.
- The Committee discussed that the Ohio Roundup is an autonomous conference, and is not subject to any one Area of AA or any Intergroup within the State the conference is independent.
