36th Ohio Roundup (Canton 2018) Host Update

Lisa Y., Host Committee Chair, reported:

- \$8,695.28 balance in the Host Committee bank account
- \$80 was raised at a Campfire/S'mores fundraiser
- The Drag Bingo event with Tina Hightower on May 12th was extremely successful, raising \$1,077
- 7 scholarship requests were made for the 36th Ohio Roundup
- The Host Committee, after working with Steve K. (Columbus), purchased Event Insurance for the 36th Ohio Roundup for \$410
- Ray S. is hosting an Axe-Throwing party on Friday 6/22/18 at 6pm as a fundraiser
- As of 6/3/18, there are 50 registered for the Roundup
- Out of the 50 registered, 41 of those were "Super Early Bird." The Committee Budgeted for 20 Super Early Bird registrations, so that number exceeded expectations
- 150 Registrations are the Goal for the Roundup, Budgeted for 120
- Part of the hotel contract now requires \$7,000 to be spent on food/beverage, so the Roundup will *now* be providing a lunch on Saturday
- Because the Committee must spend more on food/beverage with the hotel than originally planned, the Host Committee is asking for donations for the hospitality room. \$500 was originally budgeted for the room
- Conference Social Activities planned
 - FRIDAY night: Drag Bingo with Tina Hightower
 - SATURDAY night: Dance
- The Committee will sell embroidered Messenger Bags at the conference

Chris S., Host Committee Programming Chair, reported:

- 2 slots were left for AA Workshops
- At this time, no Al-Anon Workshops were confirmed

37th Ohio Roundup (Toledo 2019) Bid Update

I. BYLAW AMENDMENT #1 – Election of Officers

- George C., ORSC Secretary, presented a Bylaw change proposal formalizing how the ORSC officers are elected, and to clarify the bylaws to match the practice of the ORSC, in which the entire Committee has elected the officers.
- The bylaw change affects Article IV, Section A, which deals with the Election of ORSC officers.

II. BYLAW AMENDMENT #2 – Officer Vacancies

- George C. ORSC Secretary, presented a Bylaw change proposal on how vacancies for ORSC Officers are to be handled.
- The bylaws are unclear on if/how an officer elected to fulfill a vacated position is eligible to be elected at the conclusion of that original term.
- After discussion, the Committee was unable to agree on satisfactory language for the amendment, and a suggestion was made to table the issue until the August ORSC meeting, where George C. will re-present a Bylaw Change proposal with clearer wording.

III. BYLAW AMENDMENT #3 - Non-Profit Status Recordkeeping

- George C. ORSC Secretary, presented a Bylaw change proposal dealing with the outdated wording in the current Bylaws about the Non-Profit recordkeeping.
- The current Bylaws list a specific IRS form, which may not necessarily be the best form for the group to use
- The current Bylaws show a gross receipts amount of \$25,000 to trigger an IRS form 990; however the IRS changed the threshold amount in 2011 to \$50,000.
- The current Bylaws specifically list our retained agent to maintain the group's 501(c)3 status
- After discussion, the Committee was unable to agree on satisfactory language for the amendment, and a suggestion was made to table the issue until the August ORSC meeting, where George C. will re-present a Bylaw Change proposal with clearer wording.

IV. BYLAW AMENDMENT #4 - Non-Voting Positions

- George C., ORSC Secretary, presented a Bylaw change proposal to clear up language about the Non-Voting members (Past Chair, Webmaster, Archivist).
- Although the Bylaws state that the Past Chair, Webmaster, and Archivist are Non-Voting positions, it is unclear whether they are officially part of the Committee, which affects the quorum to conduct business. A new article defining these positions as "Non-Committee Members" would clarify this.
- The current bylaws have the position of Past Chair under the Article IX "Webmaster" Bylaw.
- Under the proposal, the 3 service positions will be under a new heading titled "Non-Committee Members," so there is no need to specify "Non-voting."

Current Bylaws

IX. WEBMASTER

A non-voting service position of Webmaster will be created and filled by a person elected by the committee. The Webmaster will serve the committee and the current host city committee by keeping the Web site (www.ohioroundup.org) current and up-to-date. The Webmaster may resign with due notice to the committee, or be replaced at the discretion of the committee.⁹

A non-voting service position of past Chairperson shall commence upon expiration

of a Chairperson's elected term and continue until replaced by rotation of the current ORSC Chairperson into the role.¹⁸

X. ARCHIVIST

A. A non-voting service position of Archivist will be created and filled by a person elected by the committee. The Archivist will preserve the history of the Ohio Roundup by collecting and preserving records, banners and memorabilia as requested by the Steering Committee and the Host City.¹³
B. A storage locker shall be maintained in the city of Columbus to house the ORSC archives. There

shall be two keys that provide access to the storage locker and shall be maintained by the current Archivist and the current ORSC Chair. They key and access codes shall be passed on to the incoming Chair and Archivist when the board positions have been vacated and/or replaced.¹⁷

IV. (Continued) BYLAW AMENDMENT #4 – Non-Voting Positions

Bylaw Change: Delete Articles IX and X, and Create a New Article IX titled "Non-Committee Members;" All existing bylaws regarding the Webmaster, Past Chair, and Archivist, will be moved under the new Article IX labeled Sections A, B, and C (respectively). And to remove the words "non-voting" from each service position as the New Article IX clearly defines "Non-Committee Members."

Proposed Bylaw: "The Roundup Steering Committee shall elect the following officers:"

IX. NON-COMMITTEE MEMBERS

A. A service position of Webmaster will be created and filled by a person elected by the committee. The Webmaster will serve the committee and the current host city committee by keeping the Web site (www.ohioroundup.org) current and up-to-date. The Webmaster may resign with due notice to the committee, or be replaced at the discretion of the committee.⁹

B. A service position of past Chairperson shall commence upon expiration of a Chairperson's elected term and continue until replaced by rotation of the current ORSC Chairperson into the role.¹⁸

C. A service position of Archivist will be created and filled by a person elected by the committee. The Archivist will preserve the history of the Ohio Roundup by collecting and preserving records, banners and memorabilia as requested by the Steering Committee and the Host City.¹³

 A storage locker shall be maintained in the city of Columbus to house the ORSC archives. There shall be two keys that provide access to the storage locker and shall be maintained by the current Archivist and the current ORSC Chair. They key and access codes shall be passed on to the incoming Chair and Archivist when the board positions have been vacated and/or replaced.¹⁷
