36th Ohio Roundup (Canton 2018) Host Final Report

Lisa Y., Canton Host Committee, reported:

- 144 Registrations for the Conference
- The committee paid \$140 to the hotel after the conference for the balance for food cost
- After the conference expenses were paid, the bank balance was \$6,332.56
 - A check was given to the 37th Ohio Roundup Host Committee (Toledo) for \$800
 - \$2,000 seed money was returned to the ORSC
 - o \$3,532.56 was returned to the ORSC as **profit** from the Conference
 - Will mail Jim O. (ORSC Treasurer) the closing financial reports in December
- Stressed the importance of saving receipts for tax purposes
- Spoke about not getting tax-exempt status at Staples
- Handed over the 144 Registrations (paper & electronic) to Toledo for their use
 - An electronic copy of registrations was sent to Judy F. and Bradley T. (Toledo)
- Also gave minutes of every Bid & Host Committee meeting to George C. (ORSC Secretary)
- Spoke about the "Early Bird" registrations. On April 15, there were 41 registrations the rest of the 144 registrations came after April 15th
- The Committee enjoyed seeing ORSC Committee members at their fundraisers

37th Ohio Roundup (Toledo 2019) Host Update

Phil W., Host Committee Chair, reported:

- To date, fundraising efforts have raised over \$4,000
- The next fundraiser will be a New Year's Eve Dane hosted in Toledo
- The hotel for the Conference has *changed* due to the Holiday Inn French Quarter will be closing its doors April 1, 2019. The new hotel will be the Radison at the University of Toledo Medical Center
 - o The room rate will still be \$99/night for the Roundup Room block
 - o 120 Rooms are part of the room block, wth 80% attrition

A discussion was held about getting back-end access to the ORSC website to view and download current registration information.

A discussion was also held about sending a physical mailer to past attendees.

The Committee thanked Phil for his update.

Harry S. reported:

- Cleveland has a Bid Committee established:

- A bank account was opened with the help of Jim O. (ORSC Treasurer)
- The bid committee raised \$500 from their Halloween fundraiser
- Will be hosting a New Year's Eve local event as a fundraiser
- Looking at potential hotels. A strong possibility is the Doubletree Westlake in Independence
 - The hotel may provide 20/25 gallons of coffee per night for free
 - o Possible room rates \$109/night

I. UPDATED CONFLICT OF INTEREST

- An updated ORSC Conflict of Interest Policy was signed. George C. retained the original copy
 - o The Bylaws require all officers to annually sign a Conflict of Interest Policy

II. BYLAW AMENDMENTS

- Gerry P. discussed several clerical changes that may need to be made to the Bylaws. Specifically, Gal-AA is referred to by an outdated name in our bylaws.
- Discussion was also held about adding Attorney General filings to the Recordkeeping section of the Bylaws
- Gerry and George will present these changes during the February 19, 2019 meeting.

III. CHECKING ACCOUNTS

- The committee discussed the types of Checking Accounts that have been set up through Huntington Bank for use under the ORSC umbrella.
 - o The type of account with Huntington is a "Community Fast Track Checking"
 - Accounts need to be set up with online banking
 - The ORSC has 4 accounts (Steering Committee, Canton 36th Ohio Roundup, Toledo 37th Ohio Roundup, and Cleveland 38th Ohio Roundup)
 - Toledo had the wrong type of account setup, which resulted in the bank charging the group an extra \$20/month (this has been corrected and reversed)
- Jim O. (ORSC Treasurer) will put together a resource document for use when setting up a checking account under the ORSC umbrella

New Business (Continued)

IV. IRS 990 FILING

- Discussions were held about the ORSC continuing to pay over \$1200/year for IRS and Attorney General filings
 The group should qualify for filing a 990-N (postcard) rather than a full 990 return
- No action was taken. The Committee will discuss during the February 2019 meeting
