I. FINANCIAL RECORDKEEPING

- The cost annually to the ORSC to have the Accountant file the paperwork is \$1500+.
- Discussion was held on the simplicity of the 990-N (postcard) since the Gross receipts of the ORSC are under \$50,000 annually
- MOTT, Self is currently our Registered Agent (required with Attorney General filings), and if the Committee chose to file the required annual filings, a new Statutory Agent would need to be sought.

1. Gal-AA Name Change

CURRENT BYLAWS:

ARTICLE III – ROUNDUP HOST CITIES

..... "International Advisory Council of Homesexual Men and Women in Alcoholics Anonymous"

ADOPTED CHANGE

Change "International Advisory Council of Homesexual Men and Women in Alcoholics Anonymous" to "Gays and Lesbians in Alcoholics Anonymous (Gal-AA)"

2. Alternate Secretary claification

CURRENT BYLAWS:

ARTICLE IV – ADMINISTRATION, SECTION 5 – ALTERNATE SECRETARY

..... "The Alternate Secretary will succeed the Chairperson after two years"

ADOPTED CHANGE

Change "Chairperson" to "Secretary"

3. Add IRS to Reporting requirements

CURRENT BYLAWS:

ARTICLE VI - DISBURSEMENT OF FUND, SECTION H -

"An annual filing is due to the Ohio Attorney General on the 15th date of the fifth month following the close of the fiscal year."

ADOPTED CHANGE

Add "IRS and" so that it reads "An annual filing is due to the IRS and Ohio Attorney General on the 15th date of the fifth month following the close of the fiscal year."

4. Delete reference to Money Market account

CURRENT BYLAWS:

ARTICLE VI – DISBURSEMENT OF FUND, SECTION E-1-b

(after Checking account) "b. Money Market Account – any excess money above the annual operating expenses at a minimum \$1.00 shall be transferred to the Money Market Account to maintain Active/Open status of the account."

ADOPTED CHANGE

Delete the entire clause "b. Money Market Account....
