Jeff R., Host Committee Co-Chair, presented a written update. He also reported:

- Unfortunately, due the COVID-19 Pandemic, the Cleveland Host Committee has canceled the in-person conference scheduled for 2020.
- There will be a one-day Virtual Conference that will take place Saturday, August 29.
- Adam P. has stepped up to coordinate the 38th Ohio Roundup via a virtual platform (Zoom).
- The hotel has formally canceled the conference via e-mail, stating that the conference "is canceled due to the limitations by the Governor for COVID-19 rules."
- There may some expense to hosting the Virtual Conference for over 100+ attendees.
- \$7,027.01 is the cash balance that will be returned to the Steering Committee; this includes the \$2,000 seed money and \$5,027.01 in net proceeds from fundraising and registration.
- 5 people had paid for the registration. 3 people requested their registration be donated to the ORSC, 1 was refunded, and 1 person has not responded after two calls.

- All lead speakers and workshop facilitators have been confirmed for the Virtual Conference
- Cost for the Virtual Conference is estimated to be around \$200, which includes up to 500 people and multiple licenses
- Adam P. has offered to serve as Zoom coordinator to set up each meeting/event/workshop.
- The Host Committee is still needing help with 2 Zoom hosts per workshop (16 total)

The Cleveland Host Committee has also been hosting a daily online meeting via Zoom in support of our statewide community.

- As Cleveland wraps up, they would like the ORSC to take over the online AA meetings and oversee and/or delegate the function to the host city for the next Ohio Roundup.
- Maybe this can be achieved by hosting one Ohio Roundup meeting per week.

The Committee thanked Jeff and the entire Cleveland Host Committee for the report. The Cleveland Host Committee has done an *outstanding* job in preparation for the 38th Ohio Roundup. And although it will not be in-person, the Ohio Roundup Steering Committee would like to extend a special "thank-you" to all of the Cleveland volunteers, members, and Committee members who have worked tirelessly to prepare.

The Committee thanked Jeff for his update and commended the Cleveland Host Committee for a great job.

39th Ohio Roundup (Dayton 2021) Bid Update
