Article 3 by laws: Roundup Host Cities:

#### **New Business**

Canton arrangements for 2024 Roundup:

- Contract secured for 2024 at Holiday Inn and almost identical to 2023.
- 50 rooms for \$132.00 a night. 3:00pm check-in and 12:00pm checkout may be requested. For every 30 rooms booked per night we get one complimentary room.
  - The cut off on the block of 50 rooms is 4 weeks before the round up, July 19<sup>th</sup>. Then making reservation Ohio Roundup must be noted to get \$132.00 night rate.
- For the event our rental rate waived with our food and beverage minimum to be met at 80%. A one-time facility fee to be paid of \$500.
- A guarantee of \$4,500 for food and beverage was made.
- Menu selection can be made up until July 29, 2024.

- Payment for food due 5 days prior to Roundup and increase in food purchase can be increased 5 days prior.
- Canton Holiday in has penciled us in for 2025 and 2026. If the Roundup for 2025 is cancelled, then there is no liability as long as the hotel is notified prior to January 2025 deposit due date. If cancellation occurs after the deposit has been sent, it will not be refunded.

- Remaining committees will be thrown into a hat and participating city delegate will draw for their assignment.
